Thickness of the glove material:  $\geq 0,11$  mm

Breakthrough time (maximum wearing time):  $\geq 480$  min

The quality of the protective gloves resistant to chemicals must be chosen as a function of the specific working place concentration and quantity of hazardous substances. The exact break through time has to be obtained from the protective glove manufacturer and must be observed. Check leak tightness/ impermeability prior to use. In the case of wanting to use the gloves again, clean them before taking off and air them well.
